Chairman's Report

Welcome to the summer season at Stormont. At present, it is difficult to discern spring through the rain, but let's hope for better. At least we can watch it fall through the club house windows again!

There is positive news on our two long term initiatives, the acquisition of St Luke's tennis court and the transfer of the club into a company limited by guarantee. Further detail of the current position and explanation of the resolutions needed at the club's forthcoming annual general meeting are set out on pages 2 and 3. The committee is unanimous in its support for the changes we are making. I hope as many members as possible will attend the AGM at 8pm on 1 May 2024 in the Club House and vote in favour of the resolutions proposed. It is the perfect opportunity to ask questions about our plans and to influence what we do.

I am delighted to report that this week we signed a 125-year lease with Anchor Group for the St Luke's tennis court. This has been under negotiation for five years and, though there were no substantive differences between us and Anchor at any stage, it proved extremely difficult to obtain clarity on what Haringey would impose on us as regards assuming Anchor's Section 106 obligations for the court. With that resolved and the lease completed, we hope in the next few days to sign up the contractor we have selected for the court remediation work.

We invited five firms to propose for phase 1 and have selected one that comes highly recommended by local clubs and is in the middle of the range of possible costs. Phase 1 consists of repairing the root barriers, inserting a second root barrier outside the court on the road side, resurfacing the court, and replacing the chainlink fencing with twin wire mesh which is much more durable. The specification of the work is to a high standard. By the time we have acquired and remediated the court, the cost will be over £100,000. We are investigating possible grants, but they are likely to be modest in relation to the core cost.

Assuming that we can sign the remediation contract in the next few days, the work should have commenced by the time of the AGM. I think we have to anticipate that St Luke's is initially out of action for about three weeks. The tarmac then needs to cure for about five weeks, during which it will be marked up with temporary lines and usable, if a little slow and harsh on the tennis balls. Next, the court will be properly painted in green and red over the space of several days and phase 1 complete. We have to assume that the court will not be available for Middlesex league matches until June, even if everything goes to plan, so a number of home matches may have to be played away.

Phase 2 will be the installation of electronic gates and associated electrical supply. This is needed to comply with the Section 106 obligation Haringey imposed to make the court available to the public for "pay-toplay". ClubSpark provides the booking and access system. It will be programmed to give members preferential rights to book the court up to a fortnight ahead (as is the case now), whereas the public can only book three days ahead, so with a little planning members should not be

Phase 3 would be installation of floodlighting and building an unobtrusive shelter with toilet facilities. This would be dependent on the grants available at the time.

The transfer of the club into a company limited by guarantee should have negligible everyday effect on members, though it will assist administration and governance of the club. Just to clarify, the new company already exists, Stormont Tennis & Squash Club Limited, and will be used as the vehicle to hold the St Luke's lease and in due course take over nominal as well as beneficial ownership of the Lanchester Road freehold.

My quip about the club house windows was really not a joke. I suspect many members know the background and as police investigations are still continuing, I'll not go into much detail. The story starts with threats against one of our coaches, first by text message and then on paper. This was followed with three nighttime attacks on the club, all involving smashing windows and the third including an attempt to set fire to the coaches'



storeroom, fortunately unsuccessful. CCTV allows us to be reasonably confident that these events were perpetrated by the same person. I apologise that members have had to endure boarded windows for so long, but it was only recently that the police made some progress in identifying the culprit. Until then we had no idea of why this occurred, who this person might be and whether it might recur. The committee has undertaken risk assessments through the period to inform our decision to keep the club open and operating.

On a happier note, I want to welcome Brendon Mounter who took over from Vickie Prow running squash coaching at Stormont from January. We are sorry to lose Vickie and thank her for eight years of sterling service to squash at the club, knowing that she is now doing the same at England Squash. Many of you will also know Brendon as an excellent coach at the club in recent years. He has a strong team helping him in Daniel Moreno and Adam Edge, and we will work with them to expand the range of squash on offer at the club. The programme for summer squash is on page 6.

Paul Salter leads our tennis coaching with excellent support from Dan Shaw and Oliver Klein. Overflow coaching has been possible at Cherry Tree Wood in recent years, which was a useful resource. Unfortunately, Barnet has recently awarded exclusive coaching rights elsewhere, so Paul will be coaching more on the Lanchester Road and St Luke's courts. Members should take full advantage of that. His Junior Programme is set out on page 5.

In conclusion, there is a lot of improvement in the pipeline for Stormont. My thanks to Dinny Ravet and others on hand at the time for their tireless work with contractors, the police and others. I would ask members to bear with us if there is some disruption whilst the planned work is in progress. We will do our best to make sure that the quality of the outcome justifies the wait.

Restructuring of Stormont Tennis & Squash Club (to be read in conjunction with the AGM agenda, page 3)

Background

It has long been the intention to restructure Stormont from an unincorporated association to a company limited by guarantee. Members with a good memory will recollect that the proposal has been approved in principle at several recent annual general meetings. There are many good legal and practical reasons why the club would be better constituted as a Company, in summary so that it can contract in its own name (the old Club had to use trustees to hold property on its behalf) and so that it can benefit from the structure and certainty that the Companies Act brings to its governance. The immediate trigger has been the need for a vehicle to hold the lease of St Luke's, which the old club could not do.

St Luke's acquisition has been greatly delayed, primarily whilst clarity was obtained from Haringey regarding how the Section 106 agreement the council imposed on Anchor Group would apply to Stormont as lessee. That is now known, and Stormont will inherit the public pay-to-play obligations previously imposed on Anchor but to date unfulfilled. Thus, at the date of writing, we are on the brink of signing the lease and hopefully by the date of the AGM will have done so.

The new company, initially formed to hold the lease, was incorporated on 3 March 2024 with the four members of our restructuring committee as members and directors (Bernard Lo, Patricia Prichard, Roy Seger and me). Its Articles of Association, briefly summarised below, were approved by the committee in February. As a company limited by guarantee, there is no requirement to use the word "limited" in the company's name in general communications, so to all casual observers the club continues unchanged as Stormont Tennis & Squash Club. You will note that we have taken the opportunity to drop the "lawn" and "rackets" from the current club's official name (Stormont Lawn Tennis and Squash Rackets Club).

The use of a company limited by guarantee (CLbG) for this purpose is common and conventional. Other corporate structures are possible, for instance we considered a Community Interest Company, but a CLbG is simple and well understood, and the LTA provides model articles which we have used as the basis for ours.

Agenda item 6 to the AGM invites members of the club to note this background.

Restructure

Agenda item 7 to the AGM invites members of the club to approve the restructuring of the club. The existing club cannot be simply "converted" into a company; a new company has to be formed, into which the assets, liabilities and operations of the old unincorporated association are transferred. Although the club rules do not clearly say so, because of the significance of the transfer, this is proposed as a special resolution requiring a 75% majority to be passed. The precise terms of the transfer deed will be approved by the Committee, but essentially the CLbG takes over all the assets and operations of the club in consideration for assuming its liabilities, including its obligation to honour all members' subscriptions for the rest of the subscription year to 30 September 2024. Again, from the perspective of members, it should appear as if the club continues unchanged. It is hoped that the formal transfer will occur on 1 July. Using a quarter date simplifies the accounting.

Under agenda item 8, it is envisaged that the Board of the CLbG will be enlarged on the date of transfer (ie 1 July), with those committee members not already appointed directors of the CLbG at incorporation being invited to join the Board and become members.

As regards the rest of the membership, there is a transitional feature for the quarter to 30 September 2024. It is envisaged that club members will be enrolled as members of the CLbG when they renew for the 2024/25 subscription year. This is so that each member has the opportunity to determine whether he or she wants to take on the £1 guarantee obligation associated with membership in the event that the CLbG has to be wound up. Hopefully this is not a real issue; the maximum amount of the guarantee at £1 is trivial and the likelihood of Stormont being would up in the foreseeable future is negligible - its finances are robust as you can see from the financial statements presented under agenda item 3. Nevertheless, the committee concluded that members should not have the guarantee imposed on them by a vote at the AGM but should have

individual choice whether they wish to sign up for next year's membership which will entitle them to one share in the CLbG with its associated guarantee of £1. In the meantime, the Deed of Transfer will bind the Board to manage the CLbG in the interests of all club members, regardless of whether they have yet joined the company.

Lanchester Road property

The club owns its Lanchester Road freehold property. The beneficial interest in the property will transfer to the CLbG as part of the restructuring. However nominally the property is held in trust by two members of the club, a situation necessitated by the club, as an unincorporated association, being unable to hold title to property itself. This will change once the CLbG takes over the club. The Deed of Transfer will require that as soon as practicable, title to the Lanchester Road property is transferred to the CLbG and the trust wound up. In so doing the CLbG will need to grant the retiring trustees an indemnity and release from all liability (in effect, this is the same basis on which the CLbG is taking over the club). Agenda item 8 invites members of the club to approve this arrangement.

Key Articles

The Articles of Association set out the basis for governing the CLbG. Key clauses are:

- Objects: to operate as a tennis and squash club and any other games that may be conveniently combined with them at the club
- Guarantee: the liability of each member is limited to £1.
- Directors: maximum of 16. The board may appoint directors but at the next AGM they must stand for election by members
- Voting rights: granted to all members who have been a member of the club for at least a year except junior and non-playing members who do not have voting rights.
- Greater flexibility on the classes of playing membership offered which is at the discretion of the board
- Members' votes for a restructuring or winding up require a 75%
- Preservation of the mandatory winding up and dissolution clauses from the old rules of the club. Thus, on a winding up of the CLbG, any surplus must be split equally between the LTA and England Squash. Members cannot benefit by winding up the CLbG

A copy of the complete Articles of the CLbG are on the club's website under the club's management tab and there will be an opportunity to ask questions about them and any other aspects of the restructuring at the AGM.
